The last date of submission of Application Form for the various posts under BIND-P study is extended up to 04.10.2018.

Applications are invited for the various posts to be filled on purely temporary basis in the Indian Council of Medical Research (ICMR), Govt. of India funded time bound research project entitled “**A Multi-centric Randomized Control Trial to Assess Effectiveness of Brief Nursing Intervention for Depression in Pregnancy (BIND-P Study)**” under Dr. Ramdas Ransing, Assistant Professor (Psychiatry) and Principal Investigator of the above project.

This is an innovative, exciting, collaborative, Multidisciplinary and multi-centric research project involving four sites viz. BKL Walawalkar Rural Medical College-Ratangiri, Lady Hardinge Medical College -New Delhi, Dharward Institute of Mental Health and Neurosciences-Dharwad, Yenopoya Medical College -Manglore. The major focus of this project is to develop a brief nursing intervention for the patients with depression in pregnancy.

Terms and conditions:

1. Qualification and experience required are as per ICMR guidelines, experience shall be counted after acquiring the essential qualification; age limit and experience will be considered as on closing date.
2. Age relaxation may be considered for deserving candidates. Age relaxation will be given to the candidates belonging to SC/ST/OBC/PWD category as per Govt. of India rules & ICMR norms.
3. * If a candidate with requisite basic qualifications does not apply to these posts, Selection committee may consider the candidate with a lower qualification (Subject to approval from scientific committee of BKLWPMC and ICMR, New Delhi).
4. Canvassing in any form will result in disqualification.

5. Candidates having experience of working in ICMR projects will also be preferred.
6. Mere fulfillment of requisite essential qualification/experience does not guarantee selection.
7. For any dispute, the entire legal jurisdiction is restricted within Ratnagiri district limits in Maharashtra only.
