ii.	Required teaching staff as per Teacher : Student ratio prescribed by National Medical Commission / University norms is fulfilled.
iii.	Admission of students is subject to availability of PG recognized teachers.
iv.	Your College is required to submit an Undertaking in the prescribed format (copy enclosed) stating that the liability arising from non-compliance with the above requirements relating to teaching staff, and any consequent academic loss caused to the students, shall rest solely with the Dean/Principal of the College.

2) The following deficiencies are to be complied with:

3) If any advances, dues or affiliation fees payable to any section of the University are pending, the same shall be cleared within three (03) months. Failing such compliance, no action shall be taken on proposals received from your college regarding approval of teachers or grant of PG Recognition or other.

4) **IMPORTANT NOTES FOR STRICT ADHERANCE :**

- The College shall comply with all the provisions of the Maharashtra University of Health Sciences Act, 1998, the Statutes, Ordinances, Regulations, Directions, and all applicable norms, regulations and guidelines issued by the National Medical Commission, the State, Government and the University from time to time.
- Grant of Continuation / Extension of Affiliation for the Academic Year 2026-27 shall not confer any vested right upon the College to claim Continuation / Extension of Affiliation for

subsequent academic years. Each proposal shall be considered independently in accordance with the prevailing statutory provisions and regulatory norms.

- iii) The University reserves the right to conduct inspection (s) of the College and its attached teaching Hospital at any time during the academic year to verify compliance with statutory provisions and regulatory norms.
- iv) Failure to rectify the deficiencies within the stipulated time period shall render the College liable for appropriate action under the provisions of the MUHS Act, 1998, including withdrawal or refusal of Continuation / Extension of Affiliation, reduction of intake capacity or any other action deemed appropriate by the University.
- v) If any information, declaration or document submitted by the College is found to be false, incorrect, misleading or suppressed at any stage, the Continuation / Extension of Affiliation granted under this order shall be liable to be withdrawn without prejudice to any other action permissible under law.
- vi) No student or institution shall claim any equity or special consideration on the basis of admissions made in violation of the provisions of this order or any applicable statutory provisions.
- vii) This Continuation / Extension of Affiliation is issued for the A.Y. 2026-27 subject to the permission of National Medical Commission and / or Government of India. Further, if the permission is declined by the said authorities, this Continuation / Extension of Affiliation shall be treated as cancelled. The College is not authorized to admit students for First Year of the course until receipt of permission of the National Medical Commission and / or Government of India.
- viii) The admission shall be done only through the Competent Authorities of the State Government.
